


## PUBLIC NOTICE

I am directed to inform the public in general that with effect from 01/01/2019 issuance of the Special Permit for passenger vehicles issued U/s 88 (8) and Temporary Permit for goods vehicle above 3,000kgs RLW issued U/s 87 (1) of Motor Vehicle Act, 1988 will commence from the RTO Border Check Post situated at Dhargalim (Pernem), Dodamarg (Bicholim), Keri (Sattari), Mollem (Sanguem) and Pollem (Canacona).

The guidelines for issuance of the said permits is enclosed herewith.

**However the applicant before proceeding at the Border Check Post should ascertain that no checking report/challan issued by the officer(s) of this Department is pending, since the Special or Temporary Permit cannot be generated in such cases. The officials at the Border Check Post will be unable to issue the Permit.**

**GUIDELINES FOR ISSUANCE OF SPECIAL PERMITS AND TEMPORARY  
PERMITS AT THE BORDER CHECK POSTS FOR VEHICLES REGISTERED  
IN THE STATE OF GOA ONLY WHILE PROCEEDING TO OTHER  
STATE/STATES OF INDIA.**

**I. Documents required to be produced compulsory in Original.**

<b>1</b>	<b>Special Permit u/s 88(8) issued to Taxi (Y/B permit and AGT Permit) and Maxicab /Mini Buses/Buses covered with Contract carriage permit (All Goa Sightseeing) and covered with Private service vehicle permit.</b>
	1) Application in Form P.CO.S.P.A. stating the period or duration for which the Special Permit is needed
	2) Enclose Passenger list in duplicate with their Full name, address, age, Gender and mob. No.
	3) Detailed Tour Program in Duplicate (Mention clearly the name of the State(s) in which the vehicle will be proceeding)
	4) R.C. copy
	5) Valid Fitness Certificate
	6) Valid All-Goa Permit
	7) Valid Insurance Certificate
	8) Valid Road Tax
	9) Valid Passenger tax
	10) Valid PUC
<b>2</b>	<b>Temporary Permit u/s 87(1) issued to Goods vehicles above 3000kgs RLW covered with Goods carriage permit issued u/s 76 of MV Act, 1988.</b>
	1) Form P.Tem.A.
	2) R.C copy
	3) Valid Insurance Certificate
	4) Valid PUC
	5) Valid Road Tax
	6) Valid Fitness Certificate
	7) Valid Goa Permit

**III. Fees:**

**Special Permit – Rs. 50/- for one round trip (max. 30 days) in a calendar month.**

**Temporary Permit – Rs. 50/- for one round trip (max. 30 days) in a calendar month.**
